- Accreditation of Inspection Bodies for Construction Products Inspection

This document provides information relating to the processing of an application for accreditation of an inspection body which provides construction products inspection services. Any inspection body which is interested in seeking HKAS accreditation for its construction products inspection services is reminded to study related accreditation requirements carefully before submitting its application.

1. Accreditation Standard

The applicant inspection body shall comply with the accreditation requirements given in the following documents:

Technical Criteria for Accreditation of Inspection Bodies

This is the key document consisting of the criteria for accreditation. It consists of the ISO/IEC 17020: 2012* requirements and the HKIAS Policy on the requirements. Because of copyright issue, only an abridged version of [HKIAS 003: 2017](#) (without the ISO/IEC 17020: 2012 requirements) is available on our website. Hardcopy of the full version of HKIAS 003: 2017 is available upon request of potential applicants and relevant parties.
