HKAS Application Package - Accreditation of Scene of Crime Investigation

This document provides information relating to the processing of an application for accreditation of scene of crime investigation . Organisations interested in seeking HKAS accreditation for scene of crime investigation should study the related accreditation requirements carefully before submitting an application.

1. Accreditation Standard
