### **HKAS Application Package**

#### **- Accreditation of Inspection Bodies for Construction Products Inspection**

(申請指南中文版本見第 3 頁)

This document provides information relating to the processing of an application for accreditation of an inspection body which provides construction products inspection services. Inspection bodies interested in seeking HKAS accreditation should study related accreditation requirements carefully before submitting an application.

#### **1. Accreditation Standard**

An applicant inspection body shall comply with the accreditation requirements given in the following documents:

Technical Criteria for Accreditation of Inspection Bodies

This document consists of the ISO/IEC 17020: 2012\* requirements and the HKIAS Policy on the requirements. Because of copyright issue, only an abridged version of [HKIAS 003: 2017](#) (without the ISO/IEC 17020: 2012 requirements) is available on our website. Hardcopy of the full version of HKIAS 003: 2017 is available upon request of potential applicants and relevant parties.
