**Accreditation of Consumer Products Inspection Body**

This document provides information relating to the processing of an application for accreditation of an inspection body which provides consumer products inspection services. Any inspection body which is seeking HKAS accreditation for their consumer product inspection services is reminded to study related accreditation requirements carefully before submitting its application.

**1. Accreditation Standard**

The applicant inspection body shall comply with the accreditation requirements given in the following document:

- 1a. [HKIAS 003:2017 \(Incorporating Amendment No. 1: September 2021\)](#)  
Technical Criteria for Accreditation of Inspection Bodies

This is the key document consisting of the criteria for accreditation. It consists of the ISO/IEC 17020:2012\* requirements and the HKIAS Policy on the requirements. Because of copyright issue, only an abridged version of [HKIAS 003:2017](#) (without the ISO/IEC 17020: 2012 requirements) is available on our website. Hardcopy of the full version of HKIAS 003: 2017 is available upon request of potential applicants and relevant parties.

\*Note: ISO/IEC 17020: 2012 can be purchased through the Quality Services Division of the Innovation and Technology Commission (ITC).
