# **HKAS Application Package – Accreditation of Environmental Testing Laboratories**

This document provides information relating to the processing of an application for accreditation of a laboratory which provides environmental testing services. Any laboratory which is interested in seeking HKAS accreditation is reminded to study related accreditation requirements carefully before submitting its application.

### **1. Accreditation Standard**

The applicant laboratory shall comply with the accreditation requirements given in the following documents:
