HKAS Application Package - Accreditation of Proficiency Testing Providers

This document provides information relating to the processing of an application for accreditation of a proficiency testing (PT) provider. Any PT provider which is interested in seeking HKAS accreditation is reminded to study related accreditation requirements carefully before submitting its application.

1. Accreditation Standard

The applicant PT provider shall comply with the accreditation requirements given in the following documents:
