### **HKAS Application Package – Accreditation of Laboratories to Undertake Product Testing to The China Compulsory Certification (CCC) System**

This document provides information relating to the processing of an application for accreditation of a laboratory which provides product testing to The China Compulsory Certification (CCC) system. Any laboratory which is interested in seeking HKAS accreditation is reminded to study related accreditation requirements carefully before submitting its application.
