## **Explanatory Notes**

1. Name and registered address of the Organisation

is the name and registered address of the Organisation as recorded in the Companies Registry of the HKSAR, if the Organisation is a company which has been registered with the Companies Registry in Hong Kong. For a Government Department, it is the name and address of the Government Department. If the Organisation is a sole-proprietorship or firm, the name shall be the name of the business marked on its business registration certificate issued under the Business Registration Ordinance (Cap. 310). The address shall be the address marked on the same certificate. If the Organisation is not incorporated nor registered in HKSAR, a name and address of equivalent status under the laws of its place of incorporation or registration should be used.

2. The Authorised Representative

is the person within the Organisation with authority to enter into contractual arrangements on behalf of the Organisation. In the case if the Organisation is a sole proprietorship or firm, the authorised representative shall be the sole proprietor of the sole proprietorship, or partner of the firm as the case may be.

3. Reviewer

is a person at managerial level authorised by the Organisation to be responsible for reviewing and recording the intended use of the Accredited CAB Combined ILAC MRA Mark. He/she shall be assessed by the Organisation to be familiar with the Terms and Conditions governing the use of the Accredited CAB ILAC MRA Mark.
